#### NOTARY PUBLIC COMMISSION RENEWAL INSTRUCTIONS

THE PROCESS FOR RENEWING A NOTARY PUBLIC COMMISSION FOR THE UNITED STATES VIRGIN ISLANDS IS DONE IN TWO (2) PHASES

#### <u>PHASE 1</u> SUBMITTAL OF DOCUMENTS AND APPROVAL OF BOND

You <u>MUST</u> submit the Commission renewal fee of \$ 75.00, plus any **outstanding annual fees**, payable to **THE GOVERNMENT OF THE VIRGIN ISLANDS**. A Notary Bond must also be submitted with a face value of \$5,000.00, from an insurance or bonding company authorized to do business in the United States Virgin Islands <u>OR</u> you may choose to submit a Surety Bond from two (2) resident sureties who are owners, within the Virgin Islands, of real property with a value of \$10,000.00 over and above encumbrances thereon. All owners of each property must sign both the Bond and Justification of Surety. The Bond, Affidavit and Certification will be submitted to the Supreme Court for approval by the Presiding Judge.

#### PHASE 2 ISSUANCE OF COMMISSION

When the Bond is returned "APPROVED" by the Supreme Court, a Notary Public Commission will be issued in your application name with the effective and expiration dates, and your Notary Public number (NP-NNN-YY). The law governing Notary Public in the U.S. Virgin Islands will be included in your packet. You are responsible for reading the law and familiarizing yourself with its provisions. ## **Quick Facts**

- A notary <u>must</u> notify this office of any changes to the information provided on this application in writing.
- A notary must always keep a registry book/ journal no matter how many or few notaries they perform.
- The maximum fee a notary can charge by law is \$5.00 per notarial act.
- A notary is not authorized to perform marriages, certify birth, marriage/death certificates or any act that constitutes the practice of law. A notary is not an attorney and cannot practice as one.
- A notary must always be completely satisfied with the identity of the person whose signature is being notarized. A notary is not obligated to notarize a person's signature without being sure that the person is who he or she claims to be. Always check identification and be satisfied that the ID is valid.

#### CONSENT FOR CRIMINAL BACKGROUND HISTORY CHECK

Pursuant to 3 V.I.C. Section 772(4), to qualify as a Notary Public in the United States Virgin Islands, a person shall not have been convicted of any crime either within or outside of the Territory. The following information is needed to conduct a (NCIC) National Crime Information Center background check of all persons seeking to be appointed or reappointed to be a Notary Public.

I HEREBY GIVE MY PERMISSION FOR THE GOVERNMENT OF THE VIRGIN ISLANDS, OFFICE OF THE LIEUTENANT GOVERNOR, TO OBTAIN INFORMATION RELATING TO MY CRIMINAL HISTORY. THE CRIMINAL HISTORY RECORD, AS RECEIVED FROM THE REPORTING AGENCIES, MAY INCLUDE ARREST AND CONVICTION DATA. I UNDERSTAND THAT THIS INFORMATION WILL BE USED, IN PART, TO DETERMINE MY ELIGIBILITY TO BE A **NOTARY PUBLIC** IN THE **UNITED STATES VIRGIN ISLANDS**. I ALSO UNDERSTAND THAT AS LONG AS I REMAIN A NOTARY PUBLIC, THE CRIMINAL HISTORY RECORDS CHECK MAY BE REPEATED AT ANY TIME FOR CAUSE RELATED TO MY APPOINTMENT.
